#### **Construction Defect Services**

Loewke Brill also does a significant amount of Construction Defect investigation work. Construction Defect by definition means a deficiency in the design or construction of a building or structure resulting from a failure to design or construct in a reasonably workmanlike manner.

Loewke Brill has the expertise to examine defective construction work and provide a report detailing the reason for failure. We perform this service for many clients, including just some of the following:

- Insurance companies who need to find the proximate cause of a paid out loss.
- Building owners who need to determine if faulty construction is the result of design errors or poor construction.
- Property Owners who are experiencing damage (water infiltration, mold growth, etc.) but do not know the cause or the best way to stop and correct the problem.

# Synopsis of Recent Projects

#### The Hartford Insurance Job

consisted of several large mechanical and electrical projects in the Baltimore area. The jobs ranged from military bases to hospitals. The total contract values were over \$100 million dollars worth of work. Loewke Brill provided initial project assessments of each job and worked with the Hartford to negotiate completion contracts with new contractors. Loewke Brill completed their portion of the work in 2011.

#### The Hanover Insurance Job

was a defaulted mechanical contractor on a \$650 million dollar hospital project in Chicago, IL. Loewke Brill was brought in to assist with the technical issues related to the mechanical work being performed and to assist in the monitoring of the contractor being financed to complete. The project completed in 2012.

#### **The Colonial Surety Project**

was a default of a bridge contractor in Rhode Island with five open projects in various stages of completion, totaling approx. \$11 million dollars worth of work to complete. Our role was to hire replacement contractors to complete work, manage completion of all projects, and manage all payment bond claims. The owner on all five projects was Rhode Island DOT. All projects were completed in 2014.

#### \$1.5 Million Dollar Affirmative Claim

against a natural gas supplier for construction of natural gas compressor station in Pennsylvania. We developed and put together the contractors claim for damages as a result of delays and design errors. We negotiated with the general contractor, sub contractors, and owner to a final mediated positive settlement for the contractor. Mediation was concluded in 2014.

#### \$1.8 Million Dollar Affirmative Claim

against a private hospital ownership group, by a contractor for sheet metal work installed in a new addition of a hospital. We developed a claim and damages incurred by contractor as result of delays, interference and productivity losses on project. Positive settlement for contractor during mediation in 2014.

#### Defense of \$2.5 Million Dollar Claim

made by public utilities owner in Ossian, IN against a contractor for alleged faulty workmanship during construction of a new sewage treatment plant. We developed defense strategies and a defensive report that damages were the result of design errors and not defective construction. We negotiated against the owner to minimal settlement with contractor. After the settlement with the contractor, we provided owner technical data to pursue design engineer errors in a separate claim. Contractor portion settled in 2015.
